Healthy Start Risk Screening



-  Florida Statute 383.14 mandates that all pregnant women be offered the Healthy Start Risk Screening at their first prenatal visit.
-  Florida Statute 383.14 requires Healthy Start Infant (Postnatal) Risk Screening be offered to parents or guardians of all infants born in Florida before leaving the delivery facility.

Responsibility of the Healthy Start Coalition



-  The establishment and oversight of the Healthy Start system.
-  Making decisions related to the use of the State of Florida Department of Health's funding to provide services for pregnant women and children from birth to age 3.

🌸 Serves pregnant women and children birth to age 3, regardless of their socioeconomic or immigration status.

🌸 Free

🌸 Confidential

🌸 Anonymous

Access to Program



🌸 SCORING Criteria: Women who score 4 or more on the Healthy Start screen are referred for care coordination and other wraparound services that support families in reducing risk factors.

🌸 Referral based on factors other than screen score.

🌸 Self-referral.

Screening Flow Chart



Health care providers perform screen



Screens are sent to the Miami-Dade County Health Department (MDCHD) Healthy Start Data Management Office (HSDMO)



The MDCHD HSDMO forwards all screens with program consent and referrals to the Healthy Start contracted providers within 5 working days to begin Healthy Start care coordination services.

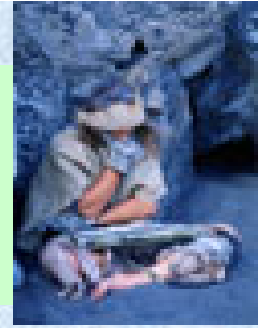
Referral for OTHER Factors

Knowledge or suspicion of:

- 🌹 Domestic violence
- 🌹 Sexual abuse
- 🌹 Child abuse or neglect
- 🌹 Substance abuse
- 🌹 Untreated mental illness including severe depression, suicidal tendencies, post-partum depression
- 🌹 History of abuse and neglect in family/household



Additional Factors, cont'd

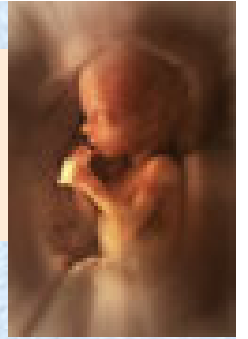


Knowledge or suspicion of:

- 🌹 Infant whose mother received no prenatal care
- 🌹 HIV Positive
- 🌹 Hepatitis B Positive
- 🌹 Lack of basic needs such as housing and food
- 🌹 Lack of health care including prenatal care
- 🌹 Inappropriate growth and development



Universal Screening Instruments



Prenatal Screen

- 🌸 Predictive of preterm birth (34 weeks since LMP) and LBW < 2000 Grams
- 🌸 40% screen positive
- 🌸 61% of adverse outcomes occur within the 40%
- 🌸 Women with positive scores are 1.8 times as likely to experience preterm birth or to have a low birth weight infant

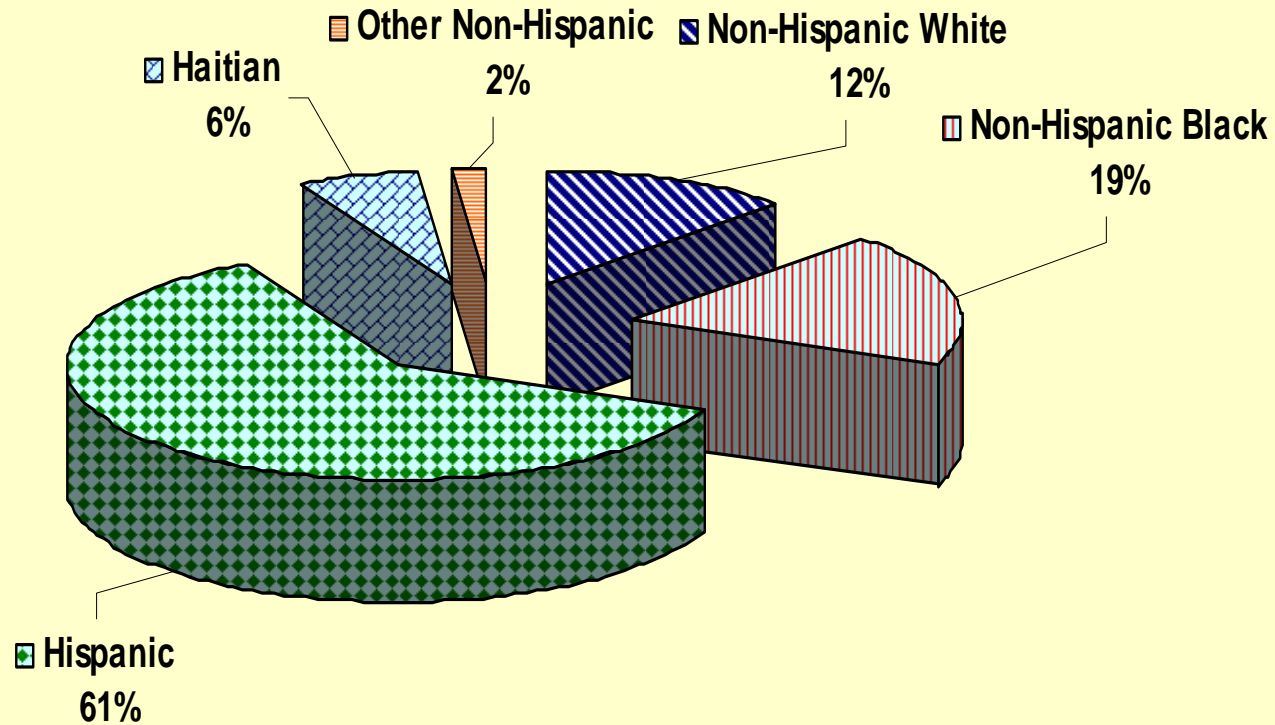
Infant Screen



- 🌸 Predictive of post-neonatal death
- 🌸 10% screen positive
- 🌸 51% of post-neonatal deaths occur within the 10%
- 🌸 Infants with positive scores are 9.1 times as likely to die during the post-neonatal period

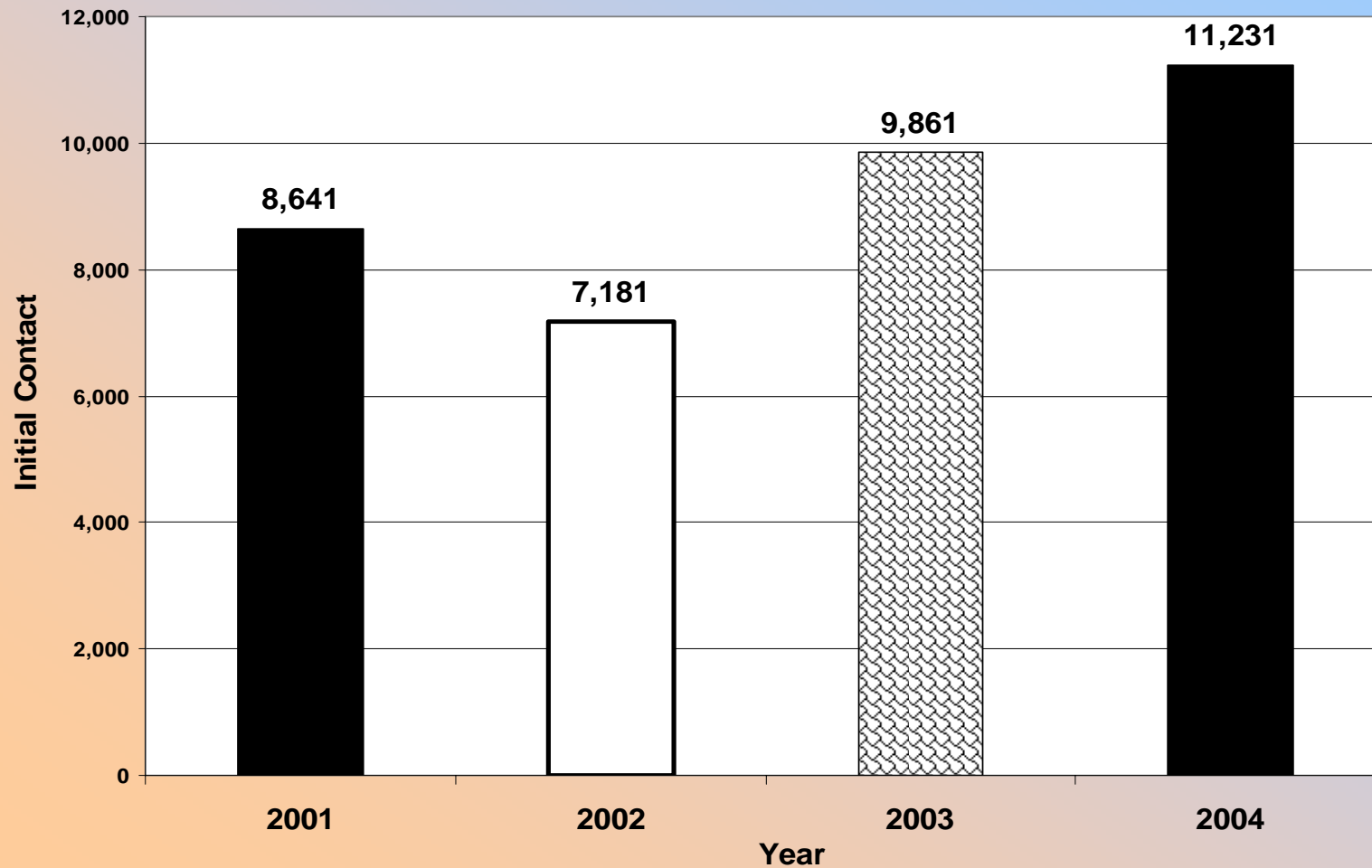
Percent Live Births by Race/Ethnicity Miami-Dade County 2003

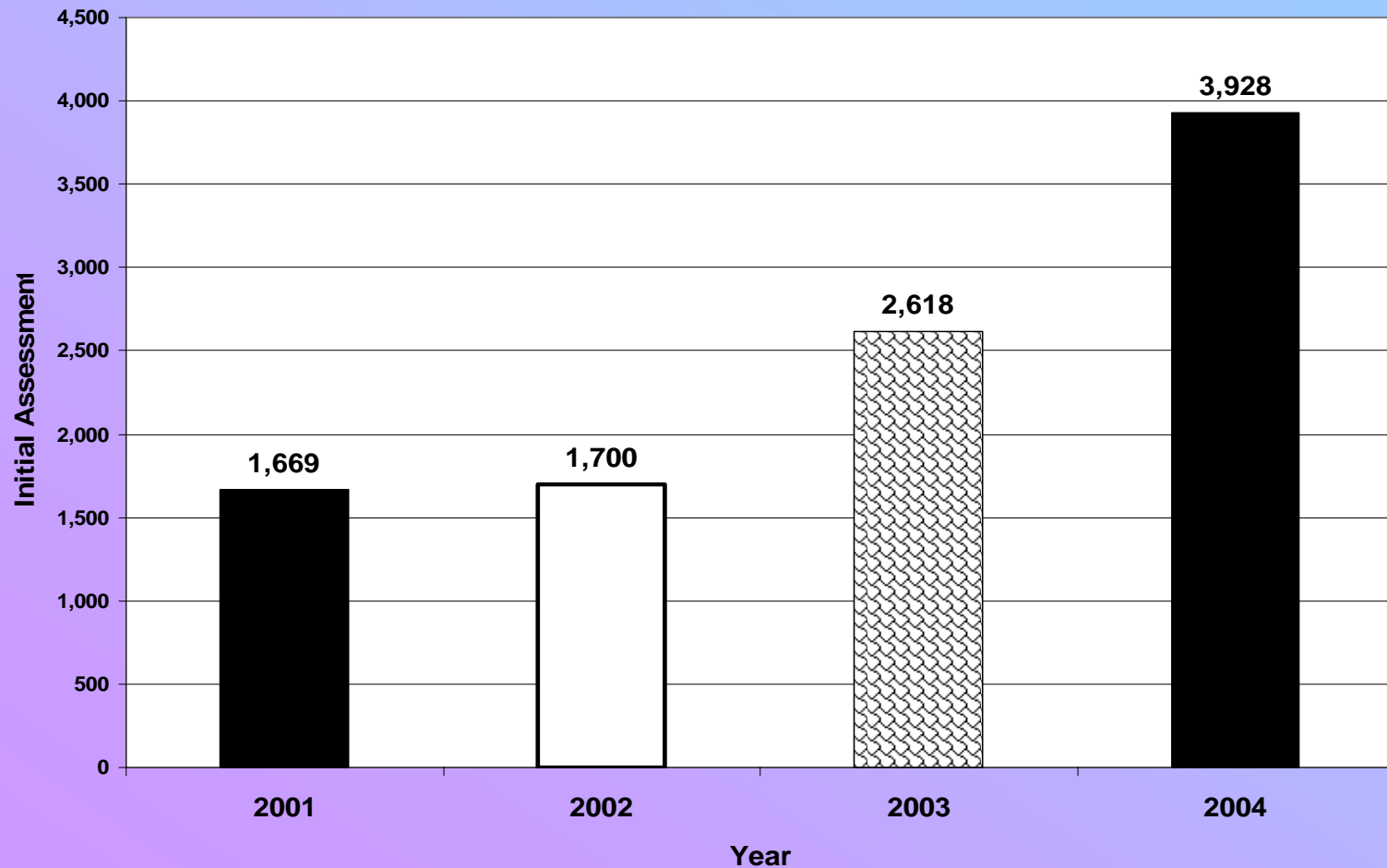

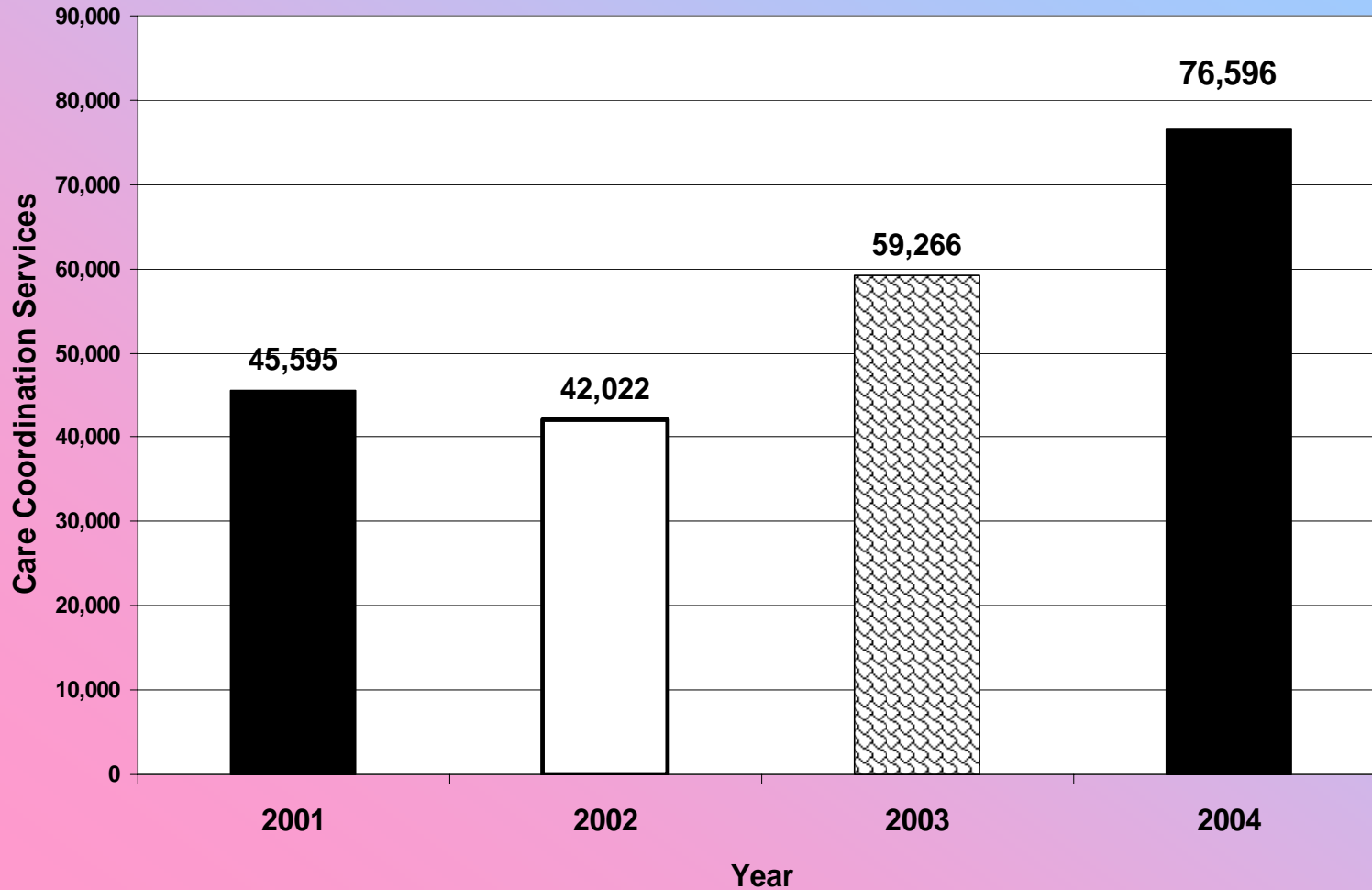

Care Coordination Services*



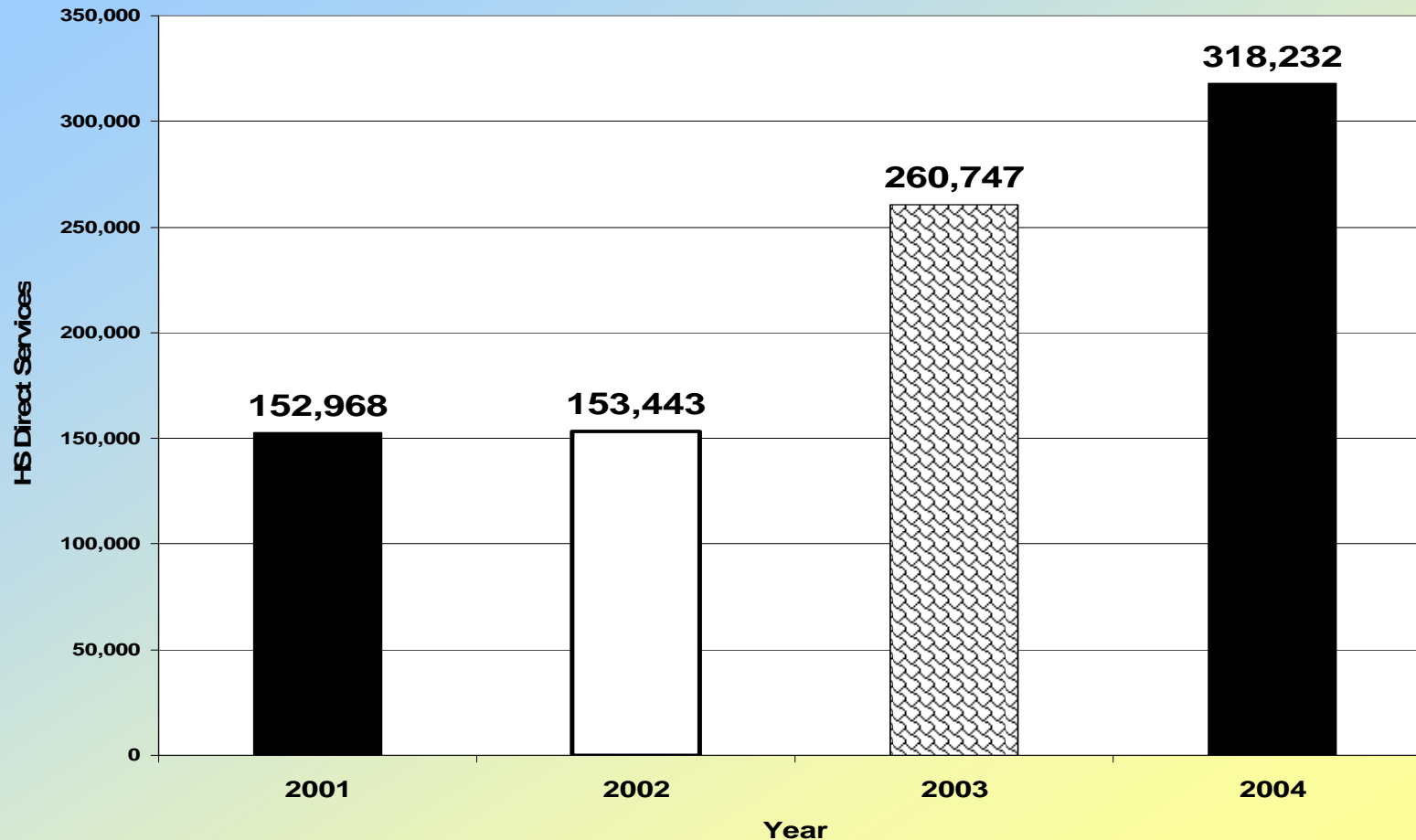

HS Direct Services*



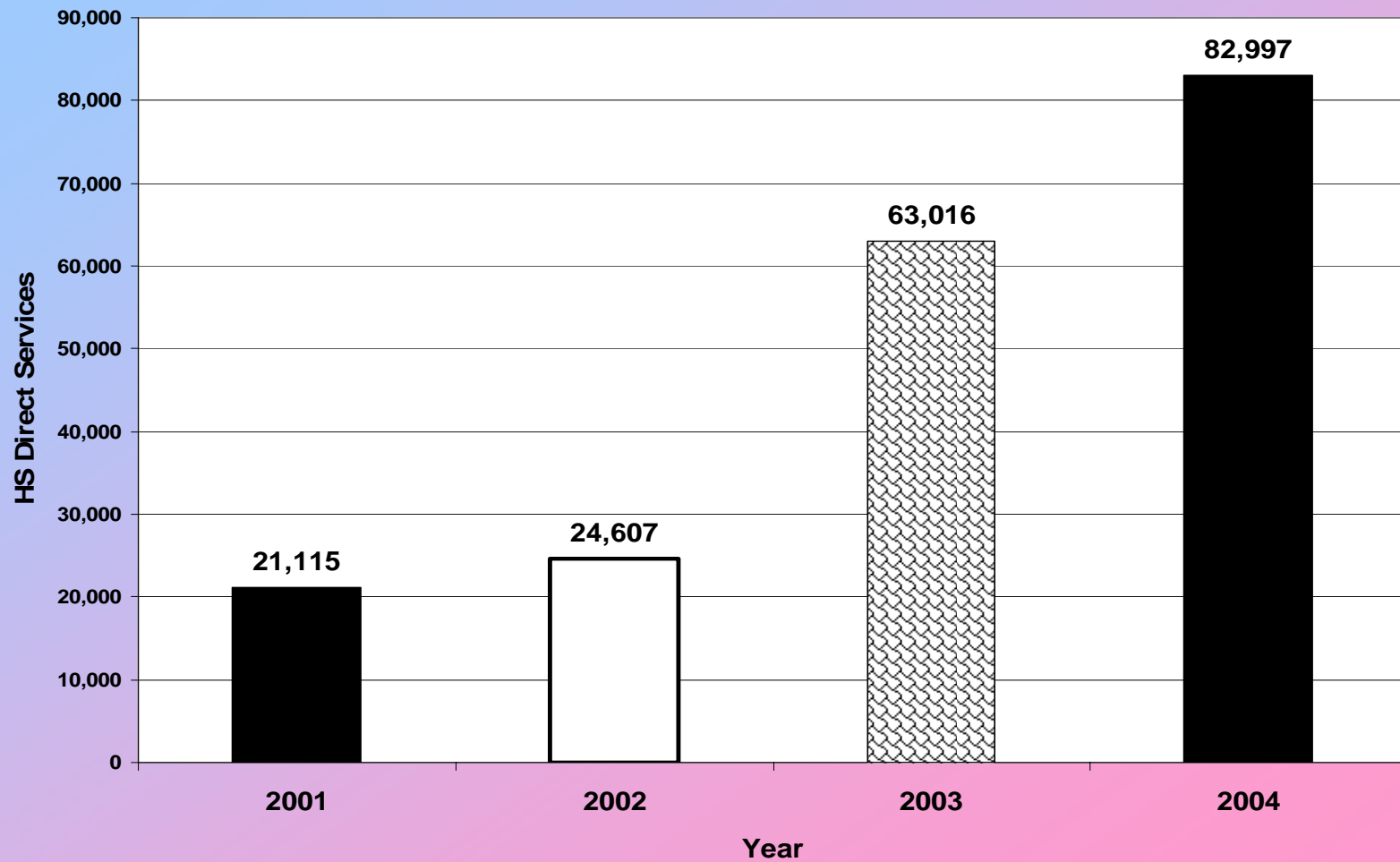

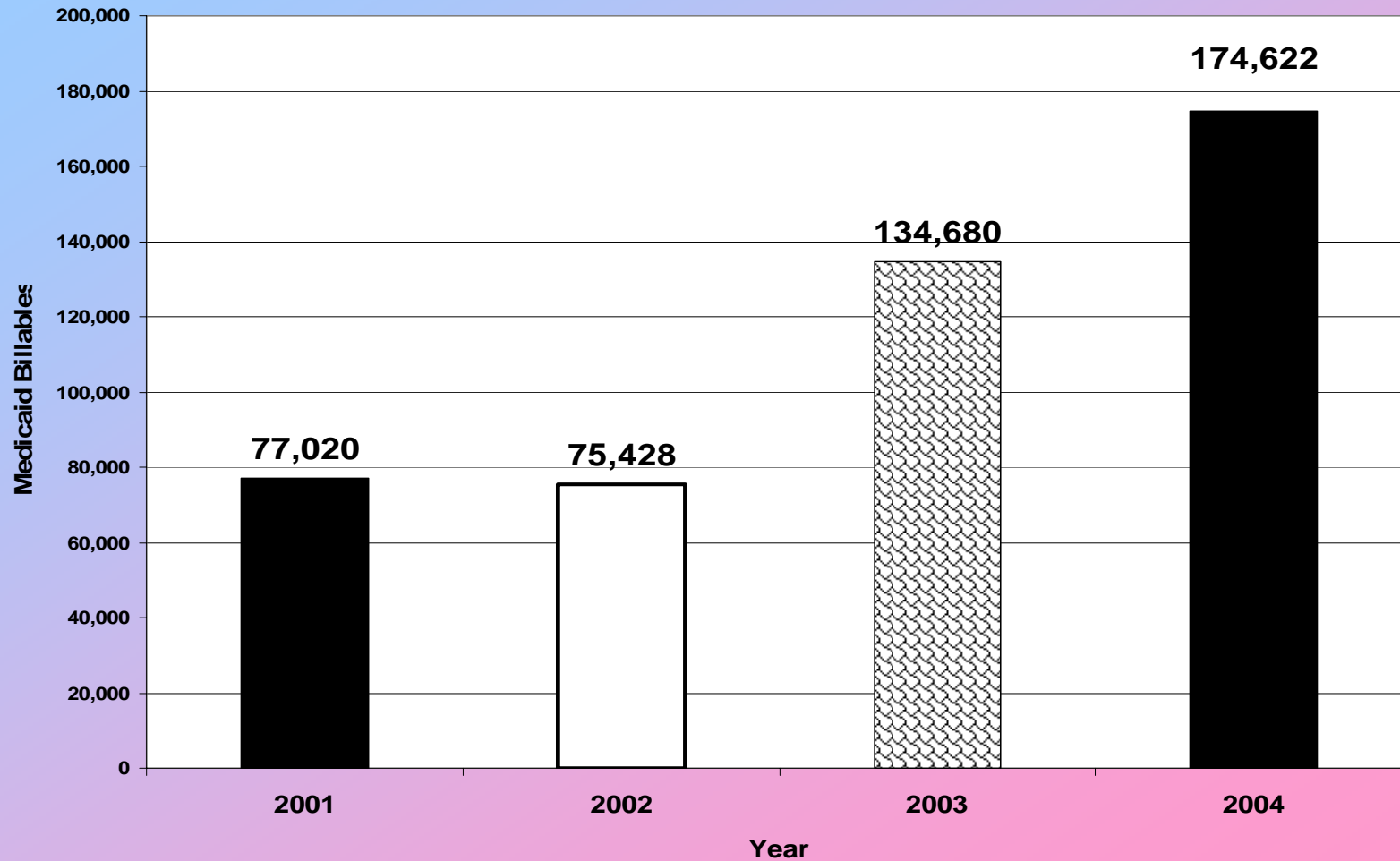

Medicaid Billables*

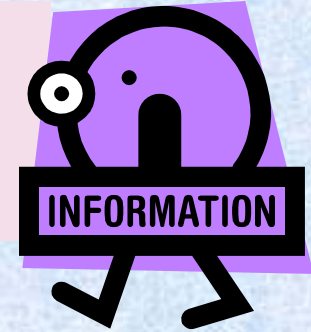
